Purpose and Scope

This Memorandum of Understanding (MoU) aims to establish a collaborative relationship between Laurel High Global School and Berzeliusskolan for mutual benefit in key areas of cooperation, including student exchange, faculty development, research, faculty exchange, and the organization of workshops and conferences.

Objectives

- 1. Promote academic excellence through collaborative initiatives.
- 2. Enhance cultural understanding and facilitate exchange programs.
- 3. Foster faculty development and encourage collaborative research.
- 4. Support student and staff mobility and provide research opportunities.

Areas of Cooperation

- 1. Student and staff Exchange Programs
- 2. Faculty Development Workshops
- 3. Joint Research Projects
- 4. Curriculum Development
- 5. Cultural Events and Exchange

Both schools shall be responsible for:

- 1. Providing necessary infrastructure and support for joint initiatives.
- 2. Nominating faculty coordinators for collaborative projects.
- 3. Facilitating student exchange programs.
- 4. Offering expertise and resources for joint research projects.
- 5. Hosting cultural events and exchange programs.
- 6. Participating in faculty development workshops.

Terms and Conditions

- 1. Duration: This MoU shall remain in effect from 11th November 2024.
- 2. Termination: This MoU may be terminated through mutual consultation and negotiation.
- 3. No Financial Liability: Neither institution shall bear any financial liability. Both institutions will explore potential funding sources to plan and execute the activities.

Implementation and Monitoring

- 1. Establish a Joint Coordination Committee to oversee implementation.
- 2. Schedule regular meetings to monitor progress and address any issues.
- 3. Develop a detailed action plan outlining specific goals and timelines.
